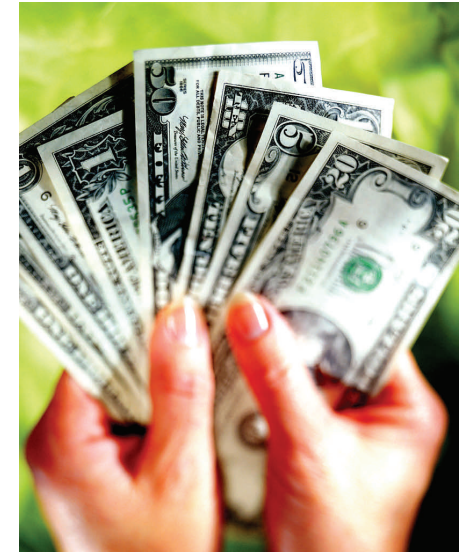

- Failure to pay this obligation or to make arrangements acceptable to PWSCC may subject me to the loss of all academic privileges within the University of Alaska system. My enrollment, dorm room, meal plan, grades, and/or transcripts may be withheld if I fail to pay my financial obligations. If employed by the University, I may be subject to an automatic payroll deduction for any missed payments.
- I understand that the Payment Plan application cost is \$25 and that fee is nonrefundable once it has been processed. The cost for textbooks may be added to the Payment Plan with a 15% one time voucher charge. Additionally, the cost of a Textbook loan is \$10 if requested independently of a Payment Plan.
- I understand that up to a \$50 late fee will be assessed to my account if for any reason my payment is not received by the PWSCC Business Office on time in accordance to this contract. Bills will not be sent.
